



California Emissions Warranty Enhancement

Re: Your 1998 GS 400 Dear Lexus Customer:

We at Lexus are dedicated to you, the customer, as well as to the environment that we all share. As part of our continual efforts to provide the best in customer satisfaction, Lexus would like to advise you of an enhancement to portions of your vehicle's California Emission Evaporative Control System Warranty Coverage.

Lexus cares about our customers

Vehicles originally sold and registered in the state of California and vehicles sold and registered in the state of Massachusetts since 1998, are covered under the California Emission Control Warranty. Specific part(s) of your vehicle's Evaporative Control System are covered for the duration described in the California Emission Control Warranty section of your Owner's Manual Supplement. Lexus is now adding a special enhancement to this coverage for certain 1996 through 1998 model year vehicles covered by the California Emission Control Warranty.

This enhanced coverage on the Evaporative Control System is extended to the components specified below for a period of 14 years or 150,000 miles from the vehicle's in-service date, whichever occurs first. Please note that, depending on the design of the evaporative control system in each model, one or more of the specified components may not apply to your vehicle.

- Evaporative storage canister
- · Evaporative system pressure sensor
- Fuel cap
- Fuel tank

- Fuel tank filler neck
- Purge valve
- · Tank vapor vent line
- Three-way valve
- Any other part or component between the fuel tank and the intake manifold (but not including the intake manifold)
 designed to contain or conduct fuel vapor from the fuel system.

This offer is limited to your specific vehicle whose VIN is provided above and to the same conditions set forth in the California Emission Control Warranty section of your *Owner's Manual Supplement*, with the exception of the additional parts and extended coverage period. Please note that this coverage is for warranty work performed at an authorized Lexus dealer only.

What should you do?

Simply insert this letter in your vehicle's Owner's Manual Supplement in the California Emission Control Warranty, Long-Term Emission System Defect Warranty Parts List section. In the future if your vehicle has a warrantable condition with any of the parts described above within the time and mileage limits of this supplemental coverage, please contact any Lexus dealer to schedule an appointment for diagnosis and, if applicable, repair. Please present this notice to the Lexus Dealer when you bring the vehicle in for your service appointment.

If you no longer own the vehicle, please utilize the enclosed postage paid form and provide us with the name and address of the new owner.

What if you have previously paid for repair or replacement of one of the components listed above?
